1. Activities reflecting the goals and objectives of the college.

In keeping with the goals and objectives which guide the activities of our institution we are constantly working towards improving our infrastructure and facilities for imparting better education to our students. Honours programmes in two new subjects, Education and Sanskrit have been introduced from the session 2015-2016. A language lab has been set up for improving the English speaking skill of the students, something which has been the Achilles heel of the majority of our mostly rural students. NSS and NCC activities aiming at the holistic development of the students mind and personality have also continued throughout the session, like in the previous years.

Many financially weak, but meritorious and deserving, general category students of our college, who do not have access to any kind of govt. stipends, are given financial aid to facilitate their higher studies.

2. New academic programmas initiated (UG and PG).

New academic programmes initiated in the sessions 2013-2014(November-June) and 2014-2015(July-June) after NAAC, 2nd cycle are Sanskrit Honours and Education Honours. The date of affiliation of both the programmes is 27th May, 2015.

3. Innovations in curricular design and transaction.

The College has limited scope in curriculum design and related innovations as transactions are centrally done by the affiliating university. However, faculty members of the college can represent in the Board of Studies meetings organized by the university. There are representation of faculty

members in the UG Council also. Curriculum design is made in the Board of Studies' meetings in discussion with the UG Council. The faculty members can express their views regarding curriculum design by the way of such representation. Moreover, faculty members can interact in the seminars/workshops organised by the Board of Studies in connection to modification of exisiting courses. Besides, a draft syllabus is circulated to various HODs as soon as it reaches.

4. Inter-Disciplinary Programmes Started.

The college could not show much achievement in this field. However, a Journal Club is recently developed where a selected faculty member delivers a speach on a special topic in presence of other teachers. A journal named *Sarvodaya: Journal of Human Development* is published in 1st January,2015 based on speeches delivered earlier.

Examination reforms are centrally made by the affiliating university with the approval of the UG Council.
